## Who:

Professional NJ-based artists 20 years & older

**Submission images of 3 different pieces.** Include at least (1) detail photo of each image. Work submitted must be indicative of, and included in exhibit, if accepted.

Accepting all types of original work, *except video\**, including: paintings, mixed media, sculpture, photography, etchings, original printmaking, woodwork, clay, glass, jewelry, metal, fabric, eco/up-cycled, etc.

*\*Due to the nature of the pop-up exhibit, we cannot guarantee adequate accessible power for video work.*

**Original Work** created in 2020 or 2021 only. If artist is accepted, original work must be at least 70% of work in exhibit.

**Active social media** account, website, blog is preferred. Mailing list for followers appreciated.

**If accepted, entrance fee** is \$50 per artist

**Application fee (\$25)** will include cost for artist's ticket to private reception, even if artist is not exhibiting.

**Each exhibiting artist will be given their own 10' x 10' space** (approximate size) to set up and arrange to best display their work. The shape of the spaces may change, depending on the exhibit location. Please check back later for additional details.

**Artists must supply their own tables, easels, pedestals, display panels, etc.** 2D work can be hung on walls in assigned space.

**No ornate frames on 2D work.** Framed work must be gallery-simple. Paintings don't require framing.

**Artist is responsible for** transporting, installing, breaking down, and cleaning up own work. MAILED OR SHIPPED WORK WILL NOT BE ACCEPTED.

**The Opening Reception is a private, ticketed event.** Every artist who applies for exhibit will be given a free ticket to the reception. All guests are required to pay to attend the reception.

### **The Arts Council of Montgomery, NJ**

Like many towns and cities throughout the country, Montgomery Township has empty commercial spaces waiting for tenants. The Arts Council is working in collaboration with local commercial property Owners to use these spaces for short-term cultural events. This Pop-Up Exhibit and Sale will be indoors.
